

SCHEME INFORMATION : PROJECT SVAVRITTI

As mandated by the Constitution, the Government of India offers many schemes for poor and marginalized citizens. These schemes are designed to protect its citizens from economic and social hardship because of loss or absence of income, housing, livelihood, and conditions such as maternity, sickness, and widowhood, old age and death. There are also schemes to promote education, delay the age of marriage for girl children, start small businesses, or to promote entrepreneurship.

Apart from schemes, there are services such as legal support given free by the government to women, and to people who cannot afford private lawyers, such as those belonging to economically backward groups, etc. Finally, the government also offers citizenship documents and entitlements such as Aadhaar card, Below Poverty Line card, Ration Card, Voter ID, etc. that serve as proof of identity and/or address, and are needed for applying to other government schemes and services.

We are carrying out a project called Svavritti that aims to help marginalized people access these government schemes, legal services and documents. We are focusing on people who belong to PLHIV communities, sexual minorities such as MSM and transgender, female sex workers, and people who inject drugs. We recognize that many of these groups find it difficult to access schemes and services either because they do not know about them, or do not have the required documents, or are not sure of the application procedure.

1. Provide detailed information on the scheme or services you identified as relevant to you and your family
2. Assess the existence of required documents for applying for the select scheme / s or services
3. On non- existence of required documents, the CRP will assist in applying for the entitlement documents with the relevant authority in the district
4. On availability of all the required documents, the CRP will assist you in filling up the application form and submitting to the concerned department
5. CRP will help you in tracking the progress of applied document with the concerned department
6. If there are previously submitted applications pending with concerned departments, the CRP will assist you in fast tracking the same

We request you to provide correct information and encourage you to clarify any of your queries with the Community Resource Person (CRP) / the State Project Coordinator.
